**RE: Upcoming Allegheny County Road Work
Camp Meeting Road (County Road No. 1061-00)**

Ms. Fleming:

The Allegheny County Department of Public Works is completing its plans for road work during this year's construction season. We expect to do the following work at some point this year:

- Milling and paving, base repairs, drainage improvements, shoulder work, and guide rail replacement on Camp Meeting Road between Beaver Street and Camp Meeting Road Extension. No detours will be needed during this work. Drivers can expect to experience short stoppages in work zones, and flaggers will be used to control traffic.
- Slope stabilization work on Camp Meeting Road. The work will require a full road closure between Charleston Square and North Lane. Residents living within the closure area will have access to their homes at all times. Traffic will be detoured using Beaver Street, Little Sewickley Road, and Fern Hollow Road.

Please note that we also plan to do some stream rehabilitation work near the 1800 block of Camp Meeting Road – at the sharp curve near Fern Hollow Road. That will not require traffic restrictions other than some possible flagging to get equipment in and out of the worksite.

All of the work likely will be performed between 6 a.m. and 6 p.m. on weekdays. When we get close to starting work, you will be notified via press release.

In anticipation of the upcoming work, please do the following:

- Forward notification of our upcoming work to your emergency services, schools, garbage service, and mail service as well as to any residents or businesses that might be impacted.
- Review all municipal-owned facilities (sidewalks, curbs, inlets, utilities, etc.) on or near the previously mentioned road to make any necessary adjustments, repairs, and debris removal prior to the start of our work.
