OLD BUSINESS

PROPOSED ORDINANCE NO. 301

AN ORDINANCE OF THE BOROUGH OF BELL ACRES, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 165 IN THE CODE OF THE BOROUGH OF BELL ACRES, "ZONING", TO AMEND THE PROVISIONS IN ARTICLE II ON "USE REGULATIONS", TO AMEND THE PROVISIONS IN ARTICLE VI ON "SIGNS", AND TO ADD A NEW PROVISION ON THE EXPIRATION OF CONDITIONAL USES.

Mr. Junker provided an update to Ordinance No. 301. This is an ordinance that Council looked at several months ago. The Ordinance was sent to the Allegheny County of Economic Development (ACED) for their comments. We received ACED's comments last week. ACED's comments were referred to the Planning Commission. If there aren't any other comments, the Borough can proceed with the Public Hearing and the Notice of Intent to Enact sometime in the future.

A motion to advertise a Notice of Intent to Enact on Proposed Ordinance No. 302 at the next Regular Meeting of March 9, 2020, was made by Mr. Wagner and seconded by Mr. Abell. All in favor. Motion carried.

ACT 537 PLAN MODIFICATION

Mr. Junker provided an update regarding Sewickley Borough's Act 537 Plan Modification. The letter was referred to Mr. Gary Irwin of Bell Acres Municipal Authority (BAMA) and Mr. Ron Brown, BAMA's Solicitor. Eric Tissue of KLH Engineers is reviewing it and checking the math. Mr. Junker hopes to have it returned in order to put together a resolution.

2020 MAJOR ROAD IMPROVEMENTS

Mr. Abell reiterated that the Borough has a 15-Year Road Improvement Plan. The plan was recently reviewed by Scott Shoup and Carl Bohn. In talking with Mr. Wagner this morning, he suggested having a "batter up" position for other roads with the thought that if the bids come in lower, then other streets could be added to the paving schedule. A lengthy discussion took place. It was noted that the "batter up" streets would be Lewis Street, Kennelly Street and Barley Road.

A motion to request Shoup Engineering, Borough Engineers, to open up the bidding process for the road work necessary to complete the 2020 portion of the Borough's 15-year Road Resurfacing Plan for no more than \$155,000.00; as per the approved 2020 Borough Budget line item for Major Road Improvements was made by Mr. Abell and seconded by Mr. Wagner. All in favor. Motion carried.

TURKEYFOOT ROAD LANDSLIDE REPAIR

Mr. Abell reported that Mr. Kulbacki tabulated figures for the cost of the landslide repair. The cost came in at less than \$86,000. This includes everything - materials and overtime. Mr. Abell exclaimed, "They did a phenomenal job!"
