Mr. Junker stated that this resolution will terminate PCS, Inc. If outstanding issues and PCS was paid for them, then they should finish project started. This resolution appoints BIU the sole inspector for the Borough.

Mr. Kulbacki – asked if we are doing this because they are cheaper? Mr. Abell asked – is this saving the Borough money? Mr. Renfrew reiterated that the issues is/was no responsiveness in some instances this past year.

Discussion of the Planning Commission and Possible Appointments of Planning Commission Members.

The discussion resulted in members of Council wanting five total Planning Commission Members or to have three members on Planning Commission (PC).

Mr. Abell and Mr. Kulbacki along with Mayor Alvania strongly agree that a five member PC be approved. This was how they have worked in the past and this has gone very well for all.

Mr. Junker stated the Municipal Planning Code (MPC) will allow Council to direct as to how many members will be on the PC. They can also have alternates if they would want to go that course.

Mr. Meanor requested a Roll Call Vote to have this discussion tabled for the January 9, 2023 Council meeting and to have other residents have the opportunity to submit a letter of interest.

Roll Call Vote:

Yes – Mr. Meanor, Mrs. Horton, Mrs. Veeck and Mr. Renfrew. **No** – Mr. Abell, Mr. Kulbacki, Mr. Grafton. The discussion will continue in the January Council meeting with the majority vote of 4 Yes.

Mr. Abell requested a straw vote to ask who at present time wants the 5 members vs. 3 members for the PC.

Mr. Renfrew was undecided at this time.
