TREASURER'S REPORT

A motion to approve the Treasurer's Report for May 2022 as distributed and ratify payments totaling \$159,740.29 out of the General Fund and \$156.66 out of the State Fund was made by Mr. Grafton, seconded by Mrs. Veeck. All in favor. Motion carried.

ORDINANCE NO. 311

AN ORDINANCE OF THE BOROUGH OF BELL ACRES, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING PART I IN THE CODE OF THE BOROUGH OF BELL ACRES, "ADMINISTRATIVE LEGISLATION", AS AMENDED, TO ADD A NEW CHAPTER 27, "ENVIRONMENTAL ADVISORY COUNCIL", AND TO THEREBY ESTABLISH, PROVIDE THE OPERATING PROCEDURES FOR, AND STAFF THE POWERS OF AN ENVIRONMENTAL ADVISORY COUNCIL FOR THE BOROUGH.

A motion to table Ordinance No. 311 – Establishing an Environmental Advisory Council until the July 11, 2022 regular meeting was made by Mr. Grafton seconded by Mrs. Veeck. All in favor. Motion carried.

COUNCIL MEMBER REPORTS Budget and Finance – MICHELLE VEECK

Mrs. Veeck spoke to Mrs. Fleming, Borough Manager regarding non-highway Diesel fuel costs. Although we cannot do anything regarding the budget now as it was approved for 2022. However, non-highway diesel fuel in summer 2021 cost was \$2.91 per gallon and current price is \$5.46 per gallon. Noted that the public works department works a shift of 6:00 am to 2:00 pm in the summer, to help alleviate the costs, although today they worked until 3:15 pm to get work done before storms rolled in. Mrs. Veeck along with Mrs. Fleming wanted to point out that as fuel prices continue to surge, it will bring us well over our fuel budget of \$8,200.
