Has your property or community been affected by **landslides**? If you are one of the many residents concerned about landslides but have seen little to no remedy through the private insurance market, please join us at a **Town Hall Meeting** to discuss our efforts to establish a Landslide Insurance and Assistance Program in Pennsylvania.

Teaming up to advance **bipartisan legislation**, we are seeking to establish a state program to assist affected homeowners and local governments to access affordable landslide and sinkhole insurance coverage at a fair price, to evaluate potential landslide risks, to provide tools and incentives to communities and individuals to mitigate potential damage caused by landslides.
