Michael Riordan - President, Quaker Valley Softball & Baseball (QVSB)

Mr. Lipton discussed the plans for the Quaker Valley Ball Park. This park has been in discussion for several years. The Quaker Valley Recreation Association (QVRA) received a \$500,000 grant for renovations to the ball park. This is a matching grant. Mr. Lipton proposed Bell Acres Borough allow in the budget to give 1% of the budget for the next several years.

This park is essential for all students and residents in the area, including all of Quaker Valley School District. The school district is helping this initiative by having an engineer work with the QVRA at the School's expense. Mr. Riordan is on the Quaker Valley School Board. The ball park is a big part of the school district and believes it will eventually be a big part of the surrounding neighborhoods including Bell Acres.

CORRECTION: Mr. Riordan is President of the Quaker Valley Softball & Baseball (QVSB). Mr. Riordan is not on the Quaker Valley School Board.
