## Request for Final Payment - Borough Park Fence - DCNR Grant

A motion to authorize final payment to be made to Schrock Fence Company, Inc. for the Borough Park Perimeter Fence and Gates in the amount of \$56,086.00 as recommended by Shoup Engineering, Inc. was made by Mr. Kulbacki, seconded by Mr. Meanor. All in favor. Motion carried.

# Borough Park Updates - DCNR Grant & ACED Grant

Phase II of the park to refurbish the basketball courts with new hoops, purchase a Gazebo near the basketball court. Replace swings and update some of the playground equipment and replace the concrete benches with several new benches. Possibly have a new smaller pavilion on the other side so more folks can have other picnic lunches if parties are in the larger one.

## The Removal Grant Project - 109 North Avenue

Shoup Engineering provided bid opening papers for the project and gather bids for the above project. The bid was awarded to J.R. Moran the low bidder, although they did not complete the bid documents, Mr. Scott Shoup of Shoup Engineering will follow through with the completed documents from J.R. Moran.
